ORDER


Whereas, necessity was felt to post accounts functionaries of appropriate level in 17 hospitals, which have been given the status of separate departments with their Medical Superintendents having been declared as HODs and keeping in mind the functional requirement of accounts functionaries in other departments, a Committee was constituted to conduct the Man Power Audit regarding requirement of accounts functionaries in the departments in the GNCT of Delhi. The report of the Committee on review and restructuring of the cadre was examined in consultation with the A.R. and Services Departments.

2. Consequent upon the review and restructuring of the accounts cadre, the Hon'ble Lt. Governor, Delhi, is pleased to order the creation/abolition/deployment of various categories of posts of accounts functionaries in Government of NCT of Delhi as per Annexure "A" to this Order.


