
Sub: Demands for Grants for the year 2022-23.

2. The Department of Law, Justice & Legislative Affairs has notified Delhi Appropriation (No.3) Act 2021 (Delhi Act 05 of 2022) vide notification dated 31.3.2022.
3. Funds as per Detailed Demands for Grants 2022-23 are available to the Departments for incurring expenditure subject to approval of Competent Authority. 
